Letter in support of HB 3047

Dear Representative Clem:

I am writing on behalf of the National Animal Interest Alliance (NAIA) in support of HB 3047, a bill that we hope will clarify the intent of the current EFU (Exclusive Farm Use) statute regarding dogs; namely that income-generating activities involving dogs are legitimate "farm uses" for land designated as EFU (Exclusive Farm Use).

Although many legislators and legal experts state that the current statute allows EFU land owners to employ their land for the income-generating dog activities offered in HB 3047, not all counties are interpreting it that way. As a result, some Oregonians have been seriously harmed, losing their livelihoods as well as their ability to provide the public with the wholesome dog activities they seek, and all for no logical reason. Dog activities have less impact on the land than many other species and are conducted in barns and other farm buildings, something that helps preserve the character of the land.

Dogs have always played a big role in Oregon. Today, nearly 40% of Oregon households, both urban and rural, keep dogs. They serve as beloved household pets, service and therapy dogs as well as maintaining their more traditional roles; herding, protecting livestock and flocks, rooting out vermin, hunting, serving as draft animals and providing comfort and protection to farm families.

Since the beginning of the 20<sup>th</sup> century, organizations like the American Kennel Club (AKC) and 4-H have provided a bridge between rural and urban lifestyles by offering activities that enable people to maintain the human-animal bond and assure an ongoing understanding and appreciation of animals and husbandry. Dog training and sports that test a dog's ability to do a particular job have been part of this tradition from the beginning and continue to this day. In Oregon, AKC events alone bring in more than \$18 million to the state economy each year. Many other clubs, organizations and businesses generate additional millions, and veterinarians,

trainers, pet supply stores and countless others benefit tremendously from the economic impact of dogs and dog activities.

Dogs were the first species to be domesticated and the species that enabled our hunter-gatherer ancestors to domesticate other species and settle into an agrarian lifestyle. Please support HB 3047 so that no matter how urbanized Oregon becomes dogs will always retain their special place on Oregon farms.
