Existing law makes it a crime to inflict unnecessary cruelty or to abuse an animal in any manner, including, but not limited to, maliciously and intentionally maiming, mutilating, torturing, or wounding an animal. This bill would additionally make it a crime to otherwise abuse or subject a living animal to needless suffering. The bill would make it a crime for a person to maliciously and intentionally mistreat any animal even if the mistreatment does not cause physical injury. By expanding the scope of a crime, this bill would impose a state-mandated local program. Existing law requires a person who is convicted of specified crimes, including misdemeanor or felony abuse of an animal, who is granted probation to successfully complete counseling. This bill would expand that requirement to require a person convicted of an infraction for abusing an animal to complete counseling. The bill would make failure to complete counseling a misdemeanor. <p><a href="#">CA SB 1479</a></p>	<p>California Agritourism Promotion Act: agritourism civil liability. Existing law provides for the direct marketing of agricultural products, including through certified farmers’ markets.Existing law generally provides that everyone is responsible, not only for the result of their willful acts, but also for an injury occasioned to another by that person’s want of ordinary care or skill in the management of their property or person, except as specified.This bill would enact the California Agritourism Promotion Act and would define “agritourism activity” as an activity carried out on a farm, ranch, or other rural land whose primary business activity is agriculture or ranching and that allows members of the general public to view, enjoy, and participate in rural activities, as provided. The bill would require an agritourism professional to include a warning notice on signs at the agritourism location and in certain contracts, as specified. The bill would exempt an agritourism professional from civil liability for injury, loss, damage, or death of a participant of an agritourism activity resulting exclusively from an inherent risk of agritourism activity, as defined, unless the agritourism professional fails to include the warning notice in the above-mentioned signs or contracts, commits an act or omission that is grossly negligent or constitutes willful or wanton disregard for the safety of a participant, has actual knowledge or reasonably should have known of an existing dangerous condition on the land, facilities, or equipment and does not make the danger known to a participant, or knowingly permits participants to use facilities or engage in agritourism activities while under the influence of alcohol or drugs. <p><a href="#">CO SB 24-045</a></p>	<p>Modifications to Sterilization Requirements for Cats &amp; Dogs The "Pet Animal Care and Facilities Act" prohibits any animal shelter or pet animal rescue (facility) from releasing a dog or cat to a prospective owner unless the animal has been sterilized, except in cases in which sterilization would jeopardize the life or health of the dog or cat. A facility in an area with limited access to licensed veterinarians may be granted an exemption from the sterilization requirement by the commissioner of agriculture (commissioner). The bill: Removes the exemption from the sterilization requirement due to the health of the animal; and Prohibits facilities that import unsterilized dogs or cats into the state of Colorado from receiving an exemption from the commissioner.
